Employment Agency shall not be responsible for any medical costs incurred by the MDW before or during her treatment.

vi. In the event where the MDW has been tested COVID19 positive during the course of SHN and cannot enter Singapore, Employer shall be refunded as follows:

- viii. No refund will be given if the MDW has been found to breach SHN rules and regulations. Any MDW who breach SHN rules and regulations shall not be permitted to enter Singapore.
  - 3. The travel arrangement to Singapore ie. Date of Departure and Flight shall be decided by and facilitated by Equidius Services Pte Ltd and subject to the requirements that ensures the success of the program shall be advised by Equidius Services Pte Ltd.
  - 4. The Employer and EA agrees that it is the responsibility of the Employer and EA to ensure that the MDW will possess all relevant approvals and documents (including employment contracts) to enter the facility, depart from source and enter Singapore legally.
  - 5. The requirement by the Ministry of Manpower (Singapore) for all Migrant Domestic Workers arriving in Singapore to serve the mandatory Stay Home Notice (SHN) for 10 days excluding the day of arrival and any subsequent extension if required by the Ministry of Manpower /Ministry of Health or any relevant Authority remains after their arrival, remains.
  - 6. Work pass process such as Medical Check Up, Settling In program, Issuance of Work Pass and Thumb Print shall be facilitated by Employment Agency only upon successful completion of SHN in Singapore. Employer shall hire the MDW after the successful completion of the quarantine at source country, Singapore SHN and Work Pass process.
  - 7. In the event that the Employer decides not to hire the MDW Employment of the MDW at any point during the source SHN or completion of the SHN. The Employer undertakes to allow the MDW to complete and continue her journey to Singapore and bear the relevant SHN costs to Singapore. The Employer is not entitled to any refund of the above stated payment in such circumstances.
  - 8. In the event that the Employer decides to terminate the Service Agreement for whatever reason, the Employer is not entitled to any refund of the above stated payment. The Employer shall honor the terms of termination in the Service Agreement.
  - 9. If the Employer decides not to continue to hire the MDW, the EA shall take over the responsibility for the MDW and the Employer shall allow the transfer of the MDW to an Employer in Singapore and in no way jeopardize the opportunity of the MDW to secure an Employment in Singapore. Unless the MOM or MOH or any other relevant authorities does not permit the transfer.
